FAQs

How do I obtain a quote or order a vehicle?

- Speak with your local Renault dealer. They will be happy to generate quotes for yourself and guide you through the ordering process. Your closest Renault dealer can be found online at www.dealerlocator.renault.co.uk.

How do I ensure I receive the discount I am eligible for?

You will need a copy of your ACU membership card and to advise the dealer that you are eligible for discount. Your support is registered against Fleet Operator Number (FON) 80537. Placing the order against this number will ensure that you receive your discount. The support levels are outlined on the previous pages.

Do you offer finance?

We have a number of competitive finance packages available through our finance provider RCI. RCI have a bespoke scheme with fixed APRs available for all ACU members. Simply state to the dealer that you wish to use that scheme for the finance.

Can I use my own financing method?

Absolutely. You are more than welcome to purchase the vehicle through any of your own financing methods if you prefer; whether this is an external provider, your bank or with cash.

What warranty do your vehicles come with?

All vehicles come with our standard warranty; 5 Years/100,000 miles on cars and 3 Years/100,000 miles on LCVs.

Terms of Scheme

- Discounts provided under the terms of the scheme are not to be used in conjunction with any other offers apart from the special ACU finance packages available through RCI Finance (for more information please contact your dealer).
- Vehicles under the terms of the scheme may only be purchased from Renault UK Limited dealers.
- The vehicle(s) must remain in the member's name (or immediate family member) for a minimum of 12 months (DVLA keeper change audits will be monitored).
- The scheme is only applicable to new Renault vehicles.
- You or an immediate family member must hold a valid ACU membership card.
- Renault UK Limited reserves the right to modify or withdraw the terms of the scheme at any time without prior notice. The terms of support can change and will be communicated where necessary.
- Scheme Abuse: Any participating member breaching these terms and conditions will be required to repay the full discount applied immediately upon demand by Renault UK Limited.
- Dealer Margins: The Renault dealers are under no obligation to provide a minimum margin and are able to adjust their margin without prior notice.
